Addressed concerns that Laramie county clerk censure resolution came from the executive team down to the grass roots which is opposite of the proper process. State attorney addressed our concerns, he stated that the resolutions was necessary for us to pursue legal actions and this gave the party the approval from the body to continue down this path. No answer as to why the Laramie county party did not raise the concern. Resolution did pass.

Our resolution on Senate and House leadership elections failed. It felt targeted as a previous resolution from Frank Eathorn to support Rick Scott passed yet the argument on the floor for our resolution was that the party doesn't take stances on winners and losers when they are all Republicans. If we aren't here to effect legislative actions Joey is unsure what other purpose we serve the grassroots.
