Chairman Metevier reported expenses of \$12.00 for banking fee to set up the Debit Card and online account access.

Chairman Metevier reported the account has been updated to the current executive team.

Chairman Metevier reported that the County Shares are due and able to be Paid July 1st, and that the proposed shares from the state should be \$3,227.00 That after paying the county shares it would leave a balance of \$3,220.37, there is not enough money in the account to pay the 2025-2027 shares and we will need to raise money over the next 18 months.

Chairman Metevier reported on the State Meeting on May7th, 2023

Chairman Metevier reported that the Executive Team met and set priorities for the team. The Chairman started by reading Article 1-3 of the County Bylaws pertaining to the role of the CCRP. Then proceeded with the 1st priority: To focus on filling precinct positions, 2nd priority: To focus on community engagement and party growth, and 3rd priority: To Fund Raise. The Chairman says the team set a \$10,000.00 goal for this term.

Chairman Metevier states the executive team cannot meet these goals without the support and work of the body. The chairman asks for each member to set goals between

CCRP SR2023.0002 Fundraising Spending
